

Leeds Gas Ltd Service Plans Terms and Conditions.

We understand that terms and conditions are often extremely difficult to understand due to how they are written. We have tried to keep our Service Plans terms and conditions extremely clear so you know exactly what is and isn't covered.

1. Scope of Contract

1.1 Leeds Gas Ltd will provide the level of cover described within the 'Plan Summary' below subject to an initial chargeable service and inspection.

1.1 Leeds Gas Ltd will provide the level of cover described within the 'Plan Summary' below. However, there is an initial 30-day period where you cannot make a claim. This is to prevent claims on pre-existing problems and to keep premiums competitive for all our customers.

1.2 When referring to 'We' this refers to Leeds Gas Ltd

1.3 This contract is strictly a maintenance contract and is not an insurance policy. Leeds Gas Ltd is therefore not regulated by the FCA.

1.4 This plan is intended for domestic boilers only and will only carry out works at residential properties.

1.5 None of the plans below include cover for a replacement boiler, only the repair and maintenance of a current one. A price for replacement of a boiler would be quoted separately.

2. Our Plans

2.1 Saver Plan - £12.99

- Annual Boiler Service
- Annual Water Test
- Annual CO Alarm Test
- Priority Call Outs (within 6 hours)
- Out of hours Boiler Service
- Loyalty Discount on All Other Plumbing & Heating Work

2.2 Advanced Plan - £16.99

Here is what is included in our Advanced Plan:

- Annual Boiler Service
- Annual Water Test
- Annual CO Alarm Test
- Priority Call Outs (within 6 hours)
- 24 Hour Emergency Call Outs
- Out of Hours Boiler Service
- Loyalty Discount on All Other Plumbing & Heating Work
- Parts & Labour Covered (boiler only)
- Available to Landlords

2.3 Premier Plan - £24.99

Here is what is included in our Premier Plan:

- Annual Boiler Service
- Annual System Water Test
- Annual CO Alarm Test
- Priority Call Outs (within 6 hours)
- Out of hours Boiler Service
- Loyalty Discount on All Other Plumbing & Heating Work
- Inhibitor Top-up (if required)
- 24hr Emergency Callouts (within 4 hours)
- Full Cover (inc. unvented cylinder, boiler, gas pipes, radiators, radiator valves, pipes & fittings)

2.4 Installation Plan (exclusive to customers who've had their boiler installed by us) - £11.99

Here is what is included in our Installation Plan:

- Annual Boiler Service
- Annual Water Test
- Annual CO Alarm Test
- Priority Call Outs
- Loyalty Discount on All Other Plumbing & Heating Work
- 24 Hour Emergency Call Outs
- Boiler Parts & Labour Covered Under Manufacturer Warranty (depending on warranty length)

3. Components of the System

3.1. Your heating system is made up of a number of different components. The components of the heating system covered within each plan are as follows:

3.2 Saver Plan

- Boiler and all internals

3.3 Advanced Plan

- Boiler and all internals

3.4 Premier Plan

- Boiler and all internals
- Thermostatic radiator valves
- Radiators
- Heating pipework
- Unvented cylinder
- All gas supply pipes

3.5 Installation Plan

- Boiler and all internals

Below you will find information on each of the benefits within our service plans. Please refer back to 'Our Plans' above to see which items below are included in each plan.

4. Annual Service

4.1. One of our Gas Safe qualified engineers will perform the service and safety check in line with manufacturers instructions

4.2. Included in this service/safety check, we will perform the following as a minimum:

- Check emissions using a fully calibrated flue gas analyser
- Check of the inlet and working gas pressure
- Clean condensate trap
- Clean magnetic filter (if fitted)
- Clean inside of boiler case
- Gas rate if required
- Test of safety devices and all safety checks in line with Gas Safe guidelines

4.3. We will also inspect the radiators, hot water cylinder and other components for leaks or defects

4.4. A gas tightness test will be performed in certain circumstances to ensure the property is free from gas leaks

4.5. The annual service will be arranged at a time and date convenient to you and in the month of your contract renewal. Unless otherwise arranged with the contract holder beforehand.

4.6 The annual service will be carried out Monday to Friday between 9 am and 5 pm unless otherwise agreed by Leeds Gas Ltd.

4.7 All boiler services will be recorded on a certificate and issued to you once your engineer has carried out the work.

5. Annual System Water Test

5.1 We will complete a test to check the quality of system water and determine the appropriate treatment to ensure the system works at optimum efficiency, and the boiler is fully protected.

5.2 Results of the test may require additional work to be carried out on the boiler that may or may not be included depending on the plan that you are on.

6. Annual Carbon Monoxide Test

6.1 We will complete a test to check all carbon monoxide detectors in the property are working correctly once per year

6.2 If no carbon monoxide testers are present in the property we are able to fit for free

7. Priority Callouts

7.1 We will endeavour to attend all breakdowns within 6 working hours, i.e. Mon-Fri 09:00-17:00.

7.2 In the event of a breakdown being reported on Saturdays, Sundays, Bank Holidays or after 5pm, we still endeavour to attend the property within 6 hours.

7.3 The timeframes outlined above are subject to workload and availability

8. 24 Hour Emergency Callouts

8.1 We will endeavour to attend your property within 4 hours irrespective of the time of day

8.2 The timeframes outlined above are subject to workload and availability

9. Breakdown Labour Discount

9.1 Customers have the right to discounted breakdown labour based on their plan as outlined below:

Saver Plan: 0 Callouts per year

Advanced Plan: 5 Callouts per year

Premier Plan: Unlimited Callouts per year

Installation Plan: Unlimited Callouts per year

9.2. Where call outs are unlimited this is subject to fair use and adequate severity.

9.3. Parts will not be covered and will be chargeable in full

10. Out of Hours Boiler Service

10.1 Customers have access to booking boiler services outside standard trading hours giving access between 17:00-20:00 Mon- Fri and 08:00-12:00 Sat-Sun.

10.2 The timeframes outlined above are subject to workload and availability

11. Loyalty Discount on Other Services

11.1. We offer other plumbing and heating services within Leeds Gas Ltd.

As a Service Plans customer you receive a discount on the labour of our other services - this will be discussed with the on site engineer.

12. Exceptions

12.1 Any breakdown that is caused by sludge, scale or system deposits will not be covered - this will be confirmed by an independent water quality test if required (chargeable to customer if it fails)

12.2 Any breakdown that is a result of a problem with the water mains, electrical grid or gas main/meter. Including having no credit on a gas meter.

12.3 Pre-existing faults and defects in the design or installation of the system.

12.7 Any defects caused due to malicious actions, misuse or third party interference.

12.8 Any defect caused by; fire, flood, lightning, explosion, storm, frost, terrorism or the impact of any other extraneous cause.

12.9 We will not be held responsible for delays in the provision of parts from suppliers or delivery firms

13. Missing / Cancellations of Appointments

13.1 Customers that have arranged a breakdown callout or annual service are given a 2 hour slot, if the engineer attends and the customer is not available a rebooking amount of £15 is charged to re-attend.

13.2 Customers must give 24 hours notice to change an appointment date/time otherwise a rebooking fee will be charged

14. Use of Subcontractors

14.1 We reserve the right to use subcontractors to carry out any breakdowns or annual services. All subcontractors will be Gas Safe registered and vetted by us for suitability

15. Period, Renewal and Payment Contract

15.1 This contract is valid for a period of 1 year (12 months) from the date the first direct debit is collected

15.2 The contract will be automatically renewed into a monthly rolling contract unless instructed by the customer to cancel. The customer must give notice no later than 14 days before the renewal date

15.3 We reserve the right to cancel the renewal of any contract without giving a reason.

15.4 In the event of non-payment of the Direct Debit cover will be suspended until the account is brought up to date and no works will be carried out

15.5 The contract is cancelled if the customer misses 3 consecutive payments without contacting after the initial 12 months period. Failure to make payments within the initial 12 month period will result in £40 administration fee on the account along with payment to get the account balance up to date

15.6 We reserve the right to cancel any policy at any time if a customer is found to have broken any terms in these conditions.

16. Certificates

16.1 All certificates will be held electronically by Leeds Gas Ltd

16.2 Customers can request copies of any certificate at any time via email without charge.

16.3 Customers can request a hard copy of any certificate subject to a printing and postage charge of £5.

17. Cooling Off Period

17.1. Customers are entitled to a full refund within 14 days of signing the contract. Any breakdowns within this cooling-off period will be charged at the full amount in the event of cancellation.
